Updates

7. Chair Update D Blackmore

- Excess funds. We are over our \$7,500 cap which is a CRA issue. When will National shift bank accounts? We are currently with BMO. National will move to RBC and NBCSEE will have an account under the National umbrella. National CSSE will owe CRA \$ for past GST owed. How will these funds be provided?
- NAOSH CSSE NB has not been involved in any planning or approved any funds for this year. PEI and NFLD chapters have also not been involved. Role of RVP is to support not do.
- Chelana stepping down from NAOSH effective immediately. Will step up to the Treasurer role vacated by Ed.
- Not happy with the actions of the RVP (that we did not vote in). Plan is to meet with other Atlantic Chairs and discuss concerns with RVP. Believe that RVP is operating under good intentions bit may be unintentionally overstepping on Chapter's toes. He may not have a full understanding of his role as RVP. Shawn and Debra to meet with Christian to raise Chapter concerns regarding RVP role and chapter's role.
- Loss of access to NB CSSE website and emails. All Chapter emails now have to be submitted to National for distribution. Chapter has lost ability to email chapter members directly to notify of meetings, etc. Takes more pre-planning on the Chapter's end to remind members of meetings. National Help-Desk has been very helpful as per Craig Silliphant.
- What needs to be voted on at the AGM? Positions will need to be. No bylaws to be voted on.
