Presentation Details

KEYNOTE: Communication for Safety - Understanding and being understood - Allan James Moore

This presentation applies to everyone. By applying contemporary communication skills to safety in the workplace, more cohesive and functional relationships and teams can be developed, which will advance the overall safety culture.

According to data collected during previous Safety Leadership workshops conducted by Allan, having good communication skills was the main attribute that participants felt all safety leaders should possess and continually improve upon. Based on the assumption that people already have the wisdom and creativity to confront the most difficult of challenges, this presentation is designed as an interactive workshop aimed at harnessing the collective intelligence of the audience. Together with Allan, the audience will examine how communication affects safety in the workplace and explore ways to improve it.

Mind the Gap: Creating Cohesiveness in your Fit for Duty Program – Chelsey Tannahill

Many of the Fit for Duty programs utilized by safety-sensitive companies today are dominated by a focus on compliance. While compliance is important, it should serve as the *foundation* for a Fit for Duty program, not as the exclusive goal and final destination. The myopic fixation many companies have on compliance often leads to organizational and individual complacency and a lack of cohesion within the program itself. It is these conditions that allow “gaps” or blind spots that ultimately cost companies thousands of dollars, hundreds of manhours, company reputations, and sadly, worker’s lives – the very outcomes being compliant is designed to protect against.

This session will illuminate some of the common gaps within and surrounding Fit for Duty programs and provide participants with the tools and resources to increase the overall cohesiveness of their Fit for Duty program.

Bracing for Impact: How Bill 47, COVID, & WCB are about to converge on employers – Ben Barfett

Just as employers, workers, WCB contractors, and the Board itself were finally getting a grip on Bill 30, along comes another curveball. In response to a recent surge in compensation payouts, the UCP has made major changes to the Workers' Compensation Act by way of Bill 47. And while Bill 47 is likely to be beneficial over time, this aggressive mandate requires the Board to reverse course -- during a pandemic no less -- when WCB's resources are already stretched dangerously thin. This presentation examines the intersection of Bill 47 and COVID-19 with respect to:

- Key legislative changes and the associated impacts on WCB/ group premiums
- Business disruption due to increased claim complexity/severity, extended return-to-work durations, so forth
- Mitigating ergonomic injuries resulting from changing work environments and working-from-home arrangements
- Improving claims outcomes via return-to-work monitoring, early intervention tactics for short-term claims that threaten to become long-term disability
- Psychological injuries driven by a rapid rise in bullying, harassment, COVID-related burnout, and toxic workplace claims

Ethics: Right, Wrong & In Between - Jim Moroney

This thought provoking session will review the modern challenges faced by safety professionals in an ever-changing world. As the profession strives for legal recognition the expectations both ethical and legal are playing an ever-greater role. We will briefly review ethical theories and the long-term implications for the health safety professional as we will explore why we make the decisions we do and the barriers we face in making such decisions.

Business Plan for HSE – Aimee Arsenault

Your Health and Safety Program should support the growth of the business, and a health and safety professional needs to be able to demonstrate that an investment into the program will bring a return to the organization.

In this session, we will review:

1. Review the elements of a business plan
2. How to use a business plan for strategic HSE improvements; and
